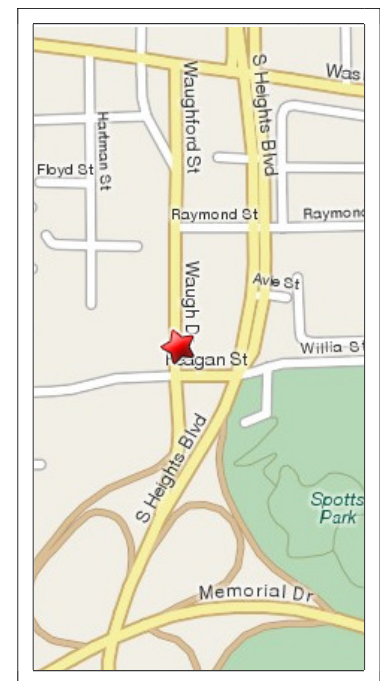
All-Neighborhood Meeting is October 16th, 7pm !!



All homeowners are invited to our next All-Neighborhood Meeting. Due to the continuing ongoing construction at St. Theresa Church, the meeting will be held at the **United Way** building at **50 Waugh Drive**. Free parking is available in the high-rise garage located on Feagan.

The building is located north of the Memorial-Waugh cloverleaf interchange at the north-west corner of Waugh and Feagan. If approaching from Washington Ave., turn right on Yale, proceed south onto Waugh, and turn right on Feagan to the garage. If approaching from Memorial, move to the left lane on Waugh when exiting the cloverleaf and proceed north. Turn left on Feagan (the first street) and proceed across Waugh to the garage.

The meeting will be held in the A-B conference room on the first floor of the Community Resource Center building.

Memorial Park Recovery Status

The drought is over, but the reforestation is just beginning. The plan to manage invasive undergrowth is proceeding in many areas of the park again. And limited tree planting will occur this Fall.

The creation of the defensible fire zone along Crestwood is complete, and no further large-scale removal of vegetation is anticipated. The foot trails in Logan Woods between Crestwood and the Park Loop road will see light vegetation removal to keep them clear and safe, and promote their use.



This continued site preparation means that no tree planting will occur this season along Crestwood. The reforestation of this section of the Park is scheduled to begin in the Fall of 2013.
